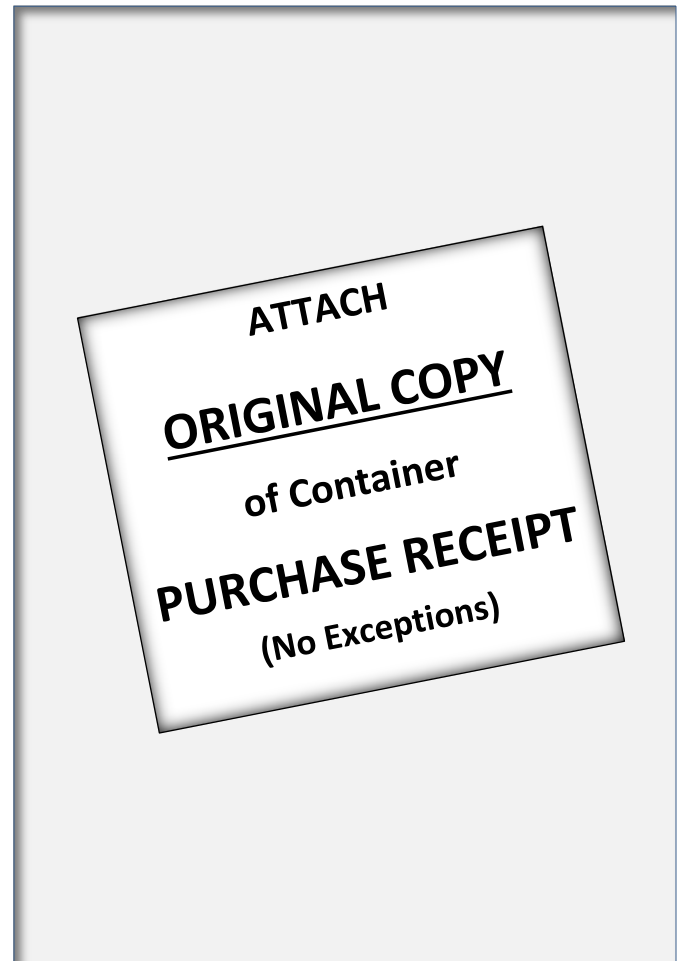

Eldorado Area Water and Sanitation District (EAWSD) RAINWATER HARVESTING CONTAINER REBATE PROGRAM REQUIREMENTS

To promote conservation of water, our most precious resource, EAWSD is now offering a rebate for purchase of **NEW** rainwater harvesting containers.



Rainwater Harvesting Container Rebate Amounts

| <u>Storage Volume</u> | | <u>Rebate</u> |
|------------------------|---|----------------------------|
| 50 to 99 gallons | = | \$15 /per container |
| 100 to 200 gallons | = | \$25 /per container |
| 200 gallons and larger | = | \$40 /per container |

***Each gallon of water you harvest, and use will save you \$\$\$!
Annual Watering Restrictions do not apply to captured water!***

Program Requirements

- Rainwater harvesting containers should be specifically designed for the harvesting and storage of rainwater **Please check with your HOA for any requirements that may not be addressed here.*
- Rainwater harvesting containers must be new, as indicated by the date of purchase on the receipt provided.
- Receipts must be provided which clearly show date of purchase, type, and size of container. If purchased online, please provide proof of purchase that has date of purchase.
- Each residential customer is eligible for rebates on a maximum of four (4) rain harvesting containers per household on the account.
- Applicant can apply for rain harvesting container rebate(s) every **10 years**.
- Applicant must be an EAWSD customer, (in good standing) with an account in their name at the address where the rain barrel is installed at the time of purchase.
- Application for rebate must be submitted within **90 days** of purchase. Rebates are not offered retroactively.

***IMPORTANT:** Your RAIN HARVESTING CONTAINER will be issued as a CREDIT to your account and **applications will be accepted in person, by mail, and at our drop boxes.**
